PAYMENT OF BAR PRACTICING FEES

All legal practitioners enrolled at the supreme court of Nigeria whether in private, public or corporate practice or working in corporate organizations are expected to pay practicing fees on a yearly basis, in accordance with the rules of professional conduct in the legal profession.

Please note that failure to pay the prescribed practicing fees as at 31st March 2008 amounts to professional misconduct, a denial of right of audience in any court and preparation of any legal document. The relevant justice sector institutions have been notified to monitor and ensure compliance.

PROCEDURES FOR PAYMENT

- . Guaranty Trust Bank (GTB Bank) has designated branches in every state where the Bar practicing fees should be paid.
- . There is a specially designed teller for payment and the depositor will retain a copy which shall be submitted to the appropriate NBA branch where the depositor is supposed to have registered. The branch shall compile a list of all depositors who submitted their tellers to the NBA National Secretariat for the issuance of practicing license for the year of payment.
- . Arrangements are also on for on-line payment

SCHEDULE OF FEES

- . Senior Advocate of Nigeria and Honorable Benchers ^20,000.00
- . Legal Practitioners of 15 years or more standing post-call ^10,000.00
- . Legal Practitioners of 10years or more standing, but less than 15 years post-call ^7,500.00
- . Legal Practitioners of 5years or more standing, but less than 15 years post-call ^4,000.00
- . Legal Practitioners of less than 5 years post-call ^2,000.00
